



Information note for the the processing personnel data for the purposes of carrying out the study “Retrospective study on a preventive and predictive medicine cohort”

1. What is this study conducted by Zoī?

The “**Retrospective study of a preventive and predictive medicine cohort**” study is set in the context of preventive and predictive medicine, essential for reducing the burden of chronic disease, improving quality of life and medium- and long-term health outcomes in the population. The main objective of this cohort study is to describe the population and data structure of Zoī members, and to provide information on preventive and predictive health through the analysis of pseudonymized real-world data. The study will offer a descriptive overview of key health indicators, such as the prevalence of chronic diseases (e.g. hypertension, diabetes, dyslipidemias), lifestyle behaviors, healthcare utilization and adherence to prevention strategies within the cohort. The study also aims to explore early trends in health outcomes, risk factors and preventive measures in a real-life setting.

The generation of preliminary data will guide future research and the development of models for predictive and preventive healthcare strategies. By analyzing the observational data collected from Zoī members, researchers will be able to explore the relationships between individual characteristics and health outcomes, enabling the development of predictive models that are likely to have a significant impact on health outcomes. This will enable the development of predictive models to support more personalized approaches to disease prevention.

The carrying out of this study presents, with regard to its purpose both, for the persons concerned, for healthcare professionals and for the healthcare system as a whole, a character of public interest in the field of healthcare (articles 6.f. and 9.2.i of the GDPR).

The study complies with deliberation no. 2018-155 of May 3, 2018 approving the reference methodology relating to the processing of personal data implemented in the context of research not involving the human person, studies and evaluations in the field of health (MR-004). 2. Who carries out the study?

The data controller for this study, i.e. the organization that decided to carry it out and is legally responsible for it, is Zoī SAS. Should you have any questions or specific requests, please

3. What data about me will be used in the study? Where does it come from and how long will it be kept?

The data to be used for the study is a combination of data already collected, and data collected on an ongoing basis when the Prevention Report is carried out.

The data already collected concerns members who have completed the Prevention Check-Up since November 2023. Data from members who complete their Prevention Check-up from December 2024 onwards will then be collected as the study progresses. No medical interventions (check-ups, complementary examinations, etc.) will be carried out for the sole purpose of the research project.

In fact, when you use these Services, data concerning you will be collected if you have given your consent: it is this data that is necessary to carry out the study.

The categories of pseudonymized data collected are as follows:

- Relevant health data from the medical questionnaire required for the Preventive Check-Up, such as medical history;
- Clinical examination data;
- Biological assessment data;
- Data on medical recommendations and possible diagnoses issued by your referring physician as part of your Preventive Check-Up ;
- Medical imaging data (OCT, CBCT, etc.).

All these data will be kept by the data controller until the final study report is signed or published.

4. Who can access my personal data?

In accordance with the law, your pseudonymized personal data will be used exclusively by authorized Zoī personnel within the limits of their respective responsibilities. Only Zoī staff and any subcontractors directly involved in the research have access to the data, and only to that which is strictly necessary for their area of competence and expertise. These staff are bound by a strict obligation of confidentiality, and can under no circumstances identify you, as directly



identifying data (such as your first and last names, or your date of birth) are excluded by nature from the scope of research projects.

In addition, your data is strictly secured, notably through encryption and pseudonymization mechanisms, to prevent unauthorized access and protect your identity. In order to comply with the articles of the French Public Health Code (article L.1111-8 du Code de la santé publique), Zoī uses the services of Amazon Web Services EMEA SARL as a certified health data host.

5. What are my rights with regard to the data concerning me used in this study?

In accordance with the legal and regulatory provisions in force, in particular Regulation (EU) 2016/679 on data protection (GDPR) and the French Data Protection Law, you have the following rights:

- Right of access: you can ask to see the personal data we hold about you and obtain a copy ;
- Right of objection: you have the possibility of objecting to the processing of your data for a specific research project, free of charge, without justification, and at any time, and without any impact on your Preventive Check-up program or the Services offered by Zoī ;
- Right of rectification: you have the right to request the modification of inaccurate or incomplete data concerning you;
- Right to erasure: you may request the deletion of your personal data, unless such deletion is likely to render impossible or seriously compromise the achievement of the research objectives.
